# CALL TO ORDER:

Carrie Harmon called the meeting to order at 2:00pm.

# **APPROVAL OF MINUTES:**

Keith Rambo moved to approve the agenda and minutes for December 2019; Samantha Wisely seconded; motion passed unanimously.

## UAA – 53 – Florida Football Training Center

## **PRESENTING: Stuart Cullen**

**DISCUSSION:** Stuart introduced himself and went over the project, the location, background, and schedule. The facility will be completely demolished and a new facility will be created on site. A portion of the retaining wall will be removed to lower the grade level of the site. This facility will include a recreation area for all student athletes and will have a lounge and a dining hall in the front of the building.

The committee asked if the design team is working with the Infirmary project for lowering the grade level, configuring gated and scooter parking. Stuart stated the design teams are working together to enhance the front of the facility to lower the grade level, add an additional parking and to plant trees and other Landscape Master Plan approved plants. There was discussion about access to the O'Connell Center parking lot, pedestrian movements and scooters.

**MOTION:** Keith Rambo made the motion to approve the project as presented. Samantha Wisely seconded motion. Motion Carried Unanimously.

# <u>UF – 642 – SW Campus Transportation Improvements</u>

## **PRESENTING: Stuart Cullen**

**DISCUSSION:** Stuart went over the project location, background, and schedule. He said he was seeking Advance Schematic Design Approval. A traffic study the University commissioned provided recommendations to make improvements to Hull Road, Mowry Road and Museum Road with two new roundabouts, turn lanes and medians. The committee asked if the transportation study included pedestrian traffic and Stuart stated this study was for vehicular traffic flow.

The project was broken out into sub area and Stuart went through each area separately. The presentation showed each median and turning lane for the roads being discussed so that it was clear what is existing and what is proposed. The presentation explained each area and how it is proposed to be reconfigured, so the committee can see what is being removed or replaced. He said he was working with the design team to try to save the heritage trees on the road.

The committee asked about the pedestrian walkways and whether there will be bike lanes and sidewalks created on both sides of the road, which Stuart went over. There was some confusion on the project so Stuart stated this presentation was for information only and that he would come back in March for the Design Development approval. The committee agreed.
